16 **INDICTMENT**

17 Defendant STEVEN JOHN BROOKS, ("BROOKS"), is accused by the Grand Jury of the
18 County of Clark, of the crime of one (1) Count of POSSESSION OF A FIREARM BY
19 PROHIBITED PERSON a Category "B" Felony in violation of NRS 202.360(1)(c), within the
20 County of Clark, State of Nevada, as follows:

21 **COUNT I**

22 **POSSESSION OF FIREARM BY PROHIBITED PERSON**

23 **NRS 202.360(1)(C) – a B Felony**

24 On or about January 19, 2013, Brooks, an unlawful user of, or being a person addicted to,
25 any controlled substance, to wit: marijuana, did unlawfully and feloniously own, or have in his
26 possession or under his custody or control any firearm to wit: 1 Smith and Wesson, silver, .357
27 Revolver, Model M65, Serial No.: CFS3150, a B felony in violation of NRS 202.360(1)(C).


