- March 20, 2013 Don Lomoljo (PUCN) contacted by Shawn Elicegui (NVE) via e-mail regarding "legislative matters"; meeting scheduled for the afternoon on March 21, 2013
- Afternoon of March 21, 2013 Telephone meeting with NVE
 - Attending: Shawn Elicegui and Mike Carano (NVE); Anne-Marie Cuneo, Garrett Weir, Don Lomoljo (PUCN)

- April 3 Senate Commerce, Labor, and Energy Meeting; NVision Amendment introduced (Amendment didn't show up on NELIS until shortly before Committee Meeting)
 - PUCN (Anne-Marie Cuneo, Garrett Weir, and Don Lomoljo) testifies in the neutral position, answered questions, stated that PUCN had not had a public meeting of the Commissioners to discuss the bill, PUCN staff still analyzing the amendment
- April 4 Anne-Marie Cuneo and Don Lomoljo receive partial information from NVE re: RG and Navajo units; no information on decommissioning/salvage values
- April 5 Anne-Marie Cuneo and Don Lomoljo receive information received from NVE on Salvage/Decommissioning

 - Attending: Governor's Office Staff, Anne-Marie Cuneo, Don Lomoljo, NVE
 - Anne-Marie Cuneo handed NVE a written request for further info. on back-up financial info, assumptions, etc.

 - Attending: Governor's Office Staff, Anne-Marie Cuneo, Tammy Cordova, NVE
- Meeting on April 11 (A.M.) At Governor's Office
 - Attending: Governor's Office Staff, Gaming Representatives, Anne-Marie Cuneo, Don Lomoljo, then NVE invited to attend by Governor's Office – NVE arrived later
- Meeting on April 11 (P.M.) At Governor's Office
 - Attending: Governor's Office Staff, Utility-Scale Renewable Developers, NVE, Anne-Marie Cuneo, Don Lomoljo
- April 11 (7:08 p.m.) Shawn Elicegui (NVE) sends via e-mail a new version of SB 123 amendment
- Meeting on April 12 (A.M.) At Governor's Office
 - Attending: Governor's Office Staff, Newmont Mining, Utility-Scale Renewable Developers, Gaming Representatives, Anne-Marie Cuneo, Don Lomoljo, NVE, Dan Jacobsen invited halfway in
 - New NVE NVision Amendment discussed
 - ***This was the last meeting at the Governor's Office attended by PUCN personnel; No further invitations to meetings at the Governor's Office have been received by PUCN personnel***
 - ***PUCN personnel attendance at Governor's Office meetings was to aid PUCN understanding of the proposal, to ask questions, and to provide technical support to anyone who asked; PUCN personnel were not authorized to negotiate, nor did they engage in negotiation***
- April 12 NVE requests a Protective Agreement in order to provide the further back-up info. requested on April 5
- April 12 (P.M.) Senate Commerce, Labor & Energy Work Session
 - New Amendment presented by NVE (didn't appear on NELIS until just before meeting)

- Pete Ernaut (NVE) when testifying implied that PUCN provided input, was supportive
- PUCN (Anne-Marie Cuneo and Don Lomoljo) invited to the table to answer questions – Don Lomoljo clarified PUCN role in meetings (listened, asked questions, provided technical support), Commission Stance (neutral)
- April 15 (6:16 pm) Responses to April 5 DRs received from NVE; provided confidentially pursuant to P.A.
- April 19 PUCN discusses April 12 version of SB 123 at length during its Agenda Meeting (Audio available on PUCN web-site)
- May 9 Don Lomoljo sends an e-mail to Shawn Elicegui (NVE) requesting updated financial information regarding SB 123 that was apparently being distributed
- May 9 Shawn Elicegui (NVE) provides via e-mail the updated financial information, a new conceptual SB 123 amendment, and other supporting summary documents
- May 11 Shawn Elicegui (NVE) sends an e-mail to Don Lomoljo inquiring if a meeting could be arranged regarding SB 123 on May 13
- May 13 Don Lomoljo sends an e-mail to Shawn Elicegui (NVE) declining a meeting because of time constraints, and advises NVE to attend the Commission's May 15 Agenda Meeting to speak in a public meeting about SB 122 (This is the only meeting invitation from NVE that was declined)
- May 15 PUCN discusses First Reprint Version of SB 123 and Conceptual Amendment provided by NVE on May 9 to Don Lomoljo and Anne-Marie Cuneo (Audio Available on PUCN web-site)
 - NVE declines to attend the Agenda Meeting
 - Commission votes to oppose First Reprint and Conceptual Amendment
- May 16 (5:55 p.m.) Shawn Elicegui (NVE) e-mails a new amendment of SB 123 to Don Lomoljo
- May 17 Senate Commerce, Labor and Energy Committee Work Session
 - PUCN invited to the table to answer questions (Anne-Marie Cuneo, Don Lomoljo, and Chairman Alaina Burtenshaw)

- Chairman Burtenshaw appears because certain Senators had requested the appearance of a PUCN Commissioner and because the Commission voted to oppose First Reprint and May 9 conceptual amendment of SB 123
- SB 123 amended and do passed
- May 24 PUCN files written handout detailing primary concerns regarding Second Reprint of SB 123 with the Assembly Labor and Commerce Committee
- May 27 Assembly Labor and Commerce Committee Meeting
 - PUCN (Anne-Marie Cuneo and Don Lomoljo) testifies in neutral position
